**AN ORDINANCE AUTHORIZING THE LEASE OF SPACE TO HOPEHEALTH**

Be it enacted that Barnwell County Council hereby authorizes the lease of room number 111 in its building located at 11015 Ellenton Street, Highway 278, Barnwell South Carolina, in accordance with the terms of the lease attached hereto as Exhibit A to this ordinance.

This ordinance shall take effect after public notice and hearing upon its third and final reading and vote. Upon passage, the Chairman of Council is hereby authorized to execute documents needed to lease this property to the Grantee. Due to the frequency of requests for office space use at the DHEC building, future approvals may be done by Resolution.



**MEMORANDUM OF UNDERSTANDING  
BY AND BETWEEN  
HopeHealth  
AND  
BARNWELL COUNTY**

**THIS AGREEMENT** is made and shall be effective as of the 1st day of April, 2018, by and between Barnwell County and HopeHealth.

**WHEREAS**, HopeHealth and Barnwell County wish to provide services in an effort to assist in the provision of services for HIV/AIDS and Hepatitis C clients in Barnwell County.

Now **THEREFORE**, the parties mutually agree as follows:

1. **HopeHealth agrees to:**
  - 1.1 HopeHealth will give a rental payment of One Dollar (\$1.00) per year for one (1) office (#111), one (1) day per month.
2. **Barnwell County agrees to:**
  - 2.3 Provide office space for HopeHealth employees. The office space will include electricity, desk, and chairs.
  - 2.4 Provide an annual invoice to First Steps by January 15<sup>th</sup> of each year.

HopeHealth hereby agrees to pay Barnwell County the sum of One Dollar (\$1.00) per year. This contract is renewable yearly and is effective April 1<sup>st</sup>, 2018. This contract renewal is contingent upon satisfactory services and continuation of the anticipated level of state funding, and may be discontinued by either party with a sixty (60) day written notice.

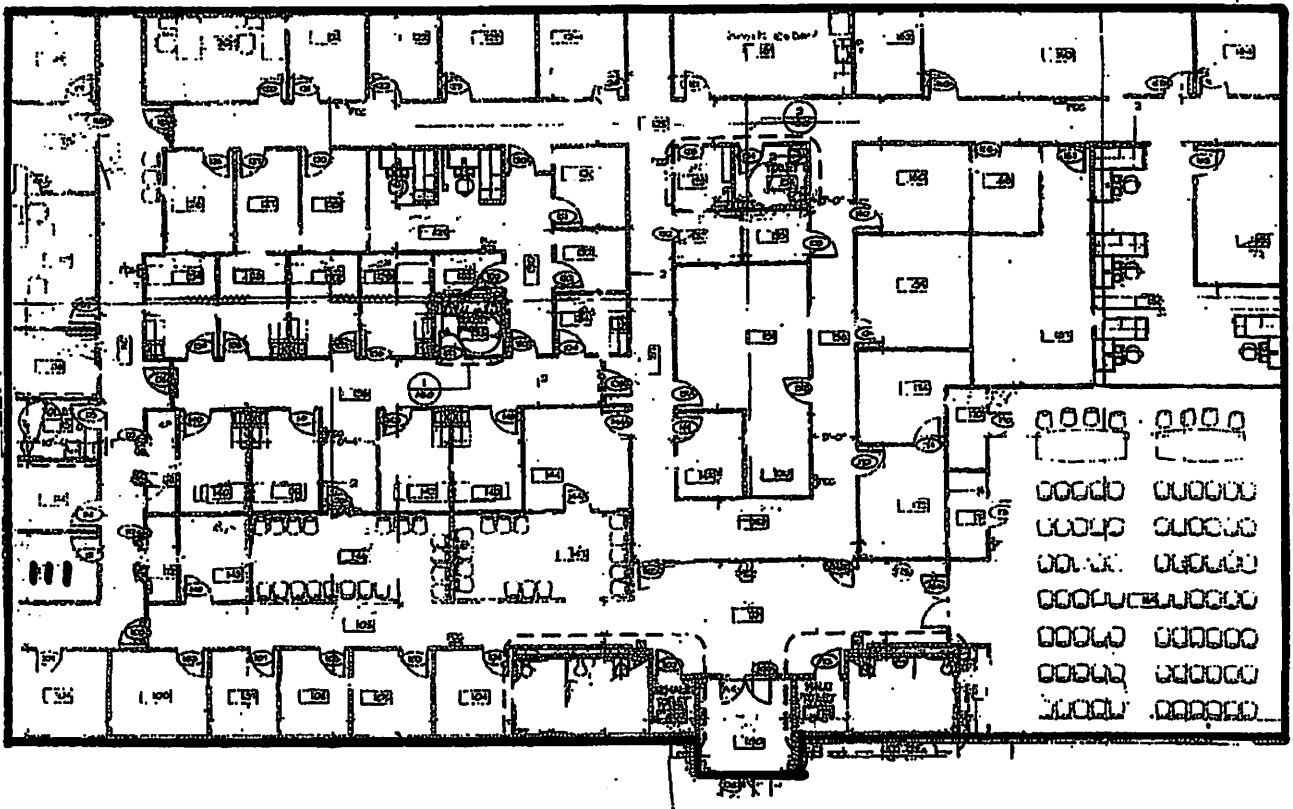
