**WHEREAS**, on June 29, 2017, Barnwell County Council passed Ordinance No. 2017-6-346-O regarding the FY 2017/2018 County Budget; and

**WHEREAS**, Section 2 of the Budget Ordinance states that the millage rate is to be set by Resolution of Council upon receipt from the County Auditor of estimated mill values for the fiscal year beginning July 1, 2017 and ending June 30, 2018, as allowed by state statutes;

**NOW, THEREFORE BE IT HEREBY RESOLVED** that the following millage rates will apply for the FY 2017/2018 budget, as confirmed by the Barnwell County Auditor, and are to the best of our knowledge, in compliance with laws limiting the millage rate:

Barnwell County Operations	147	(136 – Operations; 11 – Debt Service)
Career Center	24	(Operations/Maintenance)
Additional millage to be applied to unincorporated areas:		
	11	(Rural Fire Protection)
	4	(Public Safety in Rural Areas)

This enabling resolution shall become effective on July 1, 2017 and will confirm the projected millage rates shown in Section 2 of the FY 2017/2018 Budget Ordinance.
